## All Midwest Volleyball Insurance Liability Waiver

**\* Please read, sign and return to your coach\***

In consideration of being permitted to participate in any way in All Midwest Volleyball camp program indicated below and/or being permitted to enter for any purpose any restricted area (herein defined as any area where in admittance to the general public is prohibited), the parent(s) and/or legal guardian(s) of the minor participant named below agree:

1. The parent(s) and/or legal guardian(s) will instruct the minor participant that prior to participating in the below All Midwest Volleyball camp event, he/she should inspect the facilities and equipment to be used, and if he/she believes anything is unsafe, the participant should immediately advise the officials of such condition and refuse to participate. I understand and agreed that, if at any time, participants feel anything to be unsafe they will immediately take all precautions to avoid the unsafe area and refuse to participate further.

2. I/WE fully understand and acknowledge that:

(a) There are risks and dangers associated with participation in All Midwest Volleyball camp events, and activities, which could result in bodily injury partial and/or total disability, paralysis, and death.

(b) These risks and dangers may be caused by the action, inaction or negligence of the participant or the action, inaction or negligence of others, including, but not limited to, the Releases named below.

(c) There may be other risks not known or are not reasonably foreseeable at this time.

3. I/WE accept and assume such risks and responsibility for the losses and/or damages following such injury, disability, paralysis or death, however caused and whether caused in whole or in part by the negligence of the Releases named below.

4. I/WE HEREBY RELEASE, WAIVE, DISCHARGE AND COVENANT NOT TO SUE All Midwest Volleyball camp clinicians including its owners, officers, managers, promoters, lessees of premises used to conduct volleyball camp events, premises inspectors, underwriters, consultants and others who are involved with All Midwest Volleyball events.

5. I/WE further expressly agrees that the foregoing release, waiver, and indemnity agreement is intended to be as broad and inclusive as is permitted by the law of the state in which the event is conducted and that if any portion is held invalid, it is agreed that the balance shall, notwithstanding continue in full legal force and effect.
